

# CUB SCOUT DAY CAMP FORMS CHECKLIST

PLEASE BE SURE TO HAVE ALL OF THE FOLLOWING DOCUMENTS/ITEMS IN COMPLETION IN A PACKET TO BE HANDED IN AT THE REGISTRATION TABLE ON MONDAY MORNING. PLEASE ALSO ALLOW YOURSELF EXTRA TIME ON THAT MORNING AS THERE WILL BE A LINE AS WE CHECK EACH CAMPER'S FORMS. ANYONE WITHOUT ALL FORMS COMPLETED WILL BE ASKED TO STEP TO THE BACK OF THE LINE IN AN EFFORT TO KEEP THE LINE MOVING.

1. PARENT PICK-UP AUTHORIZATION FORM (PLEASE BE SURE TO FILL ONE OUT PER CHILD AND PER CAMP IF ATTENDING MORE THAN ONE WEEK) BE SURE TO INCLUDE EVERYONE (INCLUDING PARENTS) WHO COULD POSSIBLY TAKE YOUR CHILD HOME FROM CAMP. IF THEY ARE NOT LISTED, YOUR CHILD WILL NOT BE RELEASED TO THEM.
2. A CURRENT WALLET SIZE PHOTO OF YOUR CHILD ATTACHED TO THE UPPER RIGHTHAND CORNER OF THE FIRST PAGE OF THE MEDICAL FORM.
3. **BSA MEDICAL FORM OR THE STATE MEDICAL FORM (BLUE FORM). IF YOU SUBMIT THE STATE MEDICAL FORM YOU MUST ALSO ATTACH THE PARENT PORTION OF OUR BSA MEDICAL FORM TO IT. ALL MEDICAL FORMS MUST BE SIGNED BY THE DOCTOR AND HAVE TAKEN PLACE WITHIN ONE YEAR OF THE DATE THAT YOUR SCOUT ATTENDS CAMP. IF YOU HAVE ANY QUESTIONS OR ARE CONFUSED ABOUT WHAT IS REQUIRED PLEASE CALL CINDY PEPE (203.951.0228) FOR CLARIFICATION AS NO CHILD WILL BE ADMITTED TO CAMP WITHOUT A CURRENT AND COMPLETE MEDICAL FORM. PLEASE HOLD ON TO ALL ORIGINAL MEDICAL FORMS – MAKE COPIES TO SUBMIT WITH YOUR PACKETS – PARENTS SHOULD ALWAYS KEEP THE ORIGINAL FORMS FOR THEIR FILES.**

**\*\*PLEASE REMEMBER THAT IF YOU HAVE MORE THAN ONE SCOUT ATTENDING A CAMP – EACH SCOUT NEEDS THEIR OWN PACKET OF PAPERWORK. PLEASE DO NOT PUT MORE THAN ONE CAMPER ON ANY ONE FORM.**

**IF YOU HAVE A CAMPER ATTENDING MORE THAN ONE WEEK OF CAMP, IT IS YOUR RESPONSIBILITY TO MAKE COPIES OF THIS PACKET AND BRING IT WITH YOU ON MONDAY MORNING OF EACH WEEK. NO PAPERWORK WILL BE TRANSFERRED FROM CAMP TO CAMP.**
