The **Stewardship Society** is the premier community of dedicated supporters who believe in the power of Scouting to shape the next generation of leaders. Through **recurring contributions**, Society members ensure that every young person has access to life-changing outdoor adventures, leadership training, and community service opportunities—regardless of financial barriers. By joining, members directly fund Scouting America's core programs, keeping the spirit of adventure alive while securing the future of Scouting for generations to come. You choose your own pathway and can select to direct your gift to one of four **Society** pathways for our Scouts, with an option to support capital projects at our camps and/or leave a legacy for future Scout programs. Each giving level comes with unique recognition packages!

A Society Member's Recurring Gift

What is recurring giving? - Recurring giving is when a donor elects to make a regular, ongoing donation to Scouting instead of a one-time gift. Most often, the donor makes a commitment to a monthly donation. Quarterly and annual recurring gifts are also options. These donations are typically processed automatically through electronic payment methods like credit cards or bank transfers.



Your gift can go up to one of four ways! YOU CHOOSE!

At least **85% of your contribution** to the Stewardship Society program supports one of the four Adventure programs we offer to our Council Scouts and Units. You can choose which Scouting adventure your gift will fund and decide to allocate up to 100% of your recurring gift to the selected program. Your gift helps sustain these important programs!

Unit-Based Scouting Programs: Your contribution strengthens local Scouting units by supporting leader training, membership growth, advancement, and council services.

Outdoor Adventure Programs: Your support enhances our camp experiences by funding skilled staff, innovative programming, and critical safety infrastructure.

Community Outreach Programs: Your gift expands access to Scouting through scholarships, outdoor activities, and summer camp opportunities for underserved youth.

Maritime & Workforce Development Programs: Your donation empowers older Scouts with hands-on learning in maritime skills and workforce readiness.



Additionally: With your gift, you can also have the option to designate 15% of your gift:

- Capital Fund – to continue to build and improve Scouting facilities.
- Endowment Fund – An investment in the future of Scouting. Your contribution is designated, and the earnings support local Scouting indefinitely. Your ongoing donations will contribute toward a “James E. West” award.

Note: You can choose to give 15% of your gift to either Capital or Endowment or allocate 7.5% to each option.

INDIVIDUAL RECOGNITION

In the Stewardship Society, the donor makes a monthly, quarterly, or annual donation commitment. The commitment is a recurring gift instead of a one-time gift. These donations are typically processed automatically through electronic payment methods such as credit card or bank transfers. The donor can change their contribution preferences.



FUNDING SCOUTING



Scouting is funded in several different ways from the unit level to the national council, with the result to ensure that the Scouting movement builds character, citizenship, fitness, and leadership in the youth of our communities. Our Council's program delivery budget expends **\$589** per each traditional Scout member. **63% or \$371** of the program expenditures comes from funding our units support such as fees from summer camp and activities, product sales, and operation fees. **\$218 or 37%** of every Scout's program (scholarship) must be raised from other sources such as special event fundraisers, grants, and donations by members of our supporters such as Society members.



UNIT RECOGNITION - Packs

Reach Goal of \$1,000 through a unit presentation and five or more donors by March 31st

- Receive a \$150 Council Pack Activity or Summer Camp credit (15%) for your unit when \$1,000 is raised by 5+ individual donors!
- Receive additional \$150 Council Pack Activity or Summer Camp for each additional \$1,000 raised by 5+ individual donors!
- Credit must be used for current year programs. Includes:
 - Webelos camp at Camp Sequassen
 - Hoyt Adventure Day Camp

Units reaching or exceeding unit dollar goal by April 30th receive:

- 10% off Webelos and Arrow of Light overnight camp at Camp Sequassen
- Three weekend off-season tent camping sites at a CYC camp at no cost. (Unit picks from available dates – Fall, Winter, and Spring)

Units reaching or exceeding unit dollar goal by May 31st will receive:

- Weekend off-season campsite at a CYC camp at no cost within the current campaign year. (Unit picks from available dates in Fall, Winter, or Spring)

Units will receive a recognition ribbon for their unit flag.



UNIT RECOGNITION - Troops

Reach Goal of \$1,000 through a unit presentation and five or more donors by March 31st

- Receive a \$150 credit (15%) for your unit when \$1,000 is raised by 5+ individual donors!
- Receive additional \$150 credit for each additional \$1,000 raised by 5+ individual donors!
- Credits may be applied as an offset to leader fees or directed toward one or more Scout registrations. Credit must be used for current year reservations at CYC properties. Includes:
 - Summer camp at Camp Sequassen
 - Council NYLT

Units reaching or exceeding unit dollar goal by April 30th receive:

- 10% off Council NYLT participation fees
- Three weekend off-season tent camping sites at a CYC camp at no cost. (Unit picks from available dates – Fall, Winter, and Spring)

Units reaching or exceeding unit dollar goal by May 31st will receive:

- Weekend off-season campsite at a CYC camp at no cost within the current campaign year. (Unit picks from available dates in Fall, Winter, or Spring)

Units will receive a recognition ribbon for their unit flag.

Note: Camping sites not available from June 15 through Labor Day.
